Unfinished Business

1. Supporting Town Funding

Ron Fortier agreed to attend the January meeting of the Trenton selectboard. Trustees discussed attempts to convene the ad hoc committee with the city council and planned the next round of engagement to get some traction.

2. Fundraising Update

Artwork will be up and exhibiting beginning December 1st as well as an online auction for pieces.

3. Roofing Project

Contracted vendor has not finished the work yet.

4. Lending Policy Review

Updates to the Lending policy were reviewed by the trustees.

5. HVAC

Trustees discussed the effectiveness and limitations of our current HVAC system. Attempts to include air purification in the library's system would likely require a total rebuild.

6. COVID Planning

Trustees discussed procedures in the case of building closure as a pandemic response. Trustees reviewed staffing possibilities in case of further public building restrictions.

New Business

1. Personnel Ordinance

The new state law set to take effect January 1st, 2021 will necessitate a change to the personnel ordinance. The Library theoretically has until July 1st, 2021 to implement those changes. Trustees agreed to mirror City Council action.

2. Holiday Decorations and Planning

Trustees discussed doing some simple decorations on the library exterior.

Craig MacDonald moved to allow the Director the option to close the Library or adjust Library operations on the day of the December parade if it still takes place Anne Lusby seconded
